Current average household income is \$115,128 in this area, compared to \$80,675 for all U.S. households. Average household income is projected to be \$127,078 in five years, compared to \$91,585 for all U.S. households

Current per capita income is \$44,046 in the area, compared to the U.S. per capita income of \$30,820. The per capita income is projected to be \$48,714 in five years, compared to \$34,828 for all U.S. households

Currently, 74.2% of the 49,831 housing units in the area are owner occupied; 22.4%, renter occupied; and 3.4% are vacant. Currently, in the U.S., 55.6% of the housing units in the area are owner occupied; 33.1% are renter occupied; and 11.3% are vacant. In 2010, there were 47,656 housing units in the area - 75.3% owner occupied, 20.8% renter occupied, and 4.0% vacant. The annual rate of change in housing units since 2010 is 2.00%. Median home value in the area is \$277,478, compared to a median home value of \$207,344 for the U.S. In five years, median value is projected to change by 2.11% annually to \$308,003.
