The five-year projection for the population in the area is 151,348 representing a change of 0.92% annually from 2017 to 2022. Currently, the population is 47.9% male and 52.1% female.

Currently, 69.5% of the 60,304 housing units in the area are owner occupied; 27.4%, renter occupied; and 3.1% are vacant. Currently, in the U.S., 55.6% of the housing units in the area are owner occupied; 33.1% are renter occupied; and 11.3% are vacant. In 2010, there were 57,648 housing units in the area - 69.5% owner occupied, 25.5% renter occupied, and 5.1% vacant. The annual rate of change in housing units since 2010 is 2.02%. Median home value in the area is \$250,547, compared to a median home value of \$207,344 for the U.S. In five years, median value is projected to change by 2.37% annually to \$281,657.
