In the identified area, the current year population is 472,989. In 2010, the Census count in the area was 435,160. The rate of change since 2010 was 1.16% annually. The five-year projection for the population in the area is 497,631 representing a change of 1.02% annually from 2017 to 2022. Currently, the population is 50.2% male and 49.8% female.

The median age in this area is 34.1, compared to U.S. median age of 38.2.

Current per capita income is \$34,899 in the area, compared to the U.S. per capita income of \$30,820. The per capita income is projected to be \$39,546 in five years, compared to \$34,828 for all U.S. households

Currently, 43.5% of the 220,014 housing units in the area are owner occupied; 48.8%, renter occupied; and 7.7% are vacant. Currently, in the U.S., 55.6% of the housing units in the area are owner occupied; 33.1% are renter occupied; and 11.3% are vacant. In 2010, there were 203,988 housing units in the area - 45.3% owner occupied, 46.5% renter occupied, and 8.2% vacant. The annual rate of change in housing units since 2010 is 3.42%. Median home value in the area is \$232,575, compared to a median home value of \$207,344 for the U.S. In five years, median value is projected to change by 2.12% annually to \$258,238.
