The five-year projection for the population in the area is 267,400 representing a change of 0.94% annually from 2017 to 2022. Currently, the population is 49.1% male and 50.9% female.

The Diversity Index, which measures the probability that two people from the same area will be from different race/ethnic groups, is 67.2 in the identified area, compared to 64.0 for the U.S. as a whole.

Currently, 58.2% of the 100,983 housing units in the area are owner occupied; 36.4%, renter occupied; and 5.4% are vacant. Currently, in the U.S., 55.6% of the housing units in the area are owner occupied; 33.1% are renter occupied; and 11.3% are vacant. In 2010, there were 96,554 housing units in the area - 58.9% owner occupied, 34.5% renter occupied, and 6.6% vacant. The annual rate of change in housing units since 2010 is 2.01%. Median home value in the area is \$192,358, compared to a median home value of \$207,344 for the U.S. In five years, median value is projected to change by 2.02% annually to \$212,543.
