The Diversity Index, which measures the probability that two people from the same area will be from different race/ethnic groups, is 50.7 in the identified area, compared to 64.3 for the U.S. as a whole.

Current per capita income is \$44,108 in the area, compared to the U.S. per capita income of \$31,950. The per capita income is projected to be \$49,869 in five years, compared to \$36,530 for all U.S. households

Currently, 63.8% of the 95,329 housing units in the area are owner occupied; 30.8%, renter occupied; and 5.4% are vacant. Currently, in the U.S., 56.0% of the housing units in the area are owner occupied; 32.8% are renter occupied; and 11.2% are vacant. In 2010, there were 90,224 housing units in the area - 65.4% owner occupied, 28.9% renter occupied, and 5.7% vacant. The annual rate of change in housing units since 2010 is 2.48%. Median home value in the area is \$267,177, compared to a median home value of \$218,492 for the U.S. In five years, median value is projected to change by 1.63% annually to \$289,643.
