In the identified area, the current year population is 14,154. In 2010, the Census count in the area was 13,397. The rate of change since 2010 was 0.76% annually. The five-year projection for the population in the area is 14,721 representing a change of 0.79% annually from 2017 to 2022. Currently, the population is 49.1% male and 50.9% female.

Median Age

The median age in this area is 33.0, compared to U.S. median age of 38.2.

Current median household income is \$57,692 in the area, compared to \$56,124 for all U.S. households. Median household income is projected to be \$63,594 in five years, compared to \$62,316 for all U.S. households

Current average household income is \$77,603 in this area, compared to \$80,675 for all U.S. households. Average household income is projected to be \$88,722 in five years, compared to \$91,585 for all U.S. households

Current per capita income is \$29,522 in the area, compared to the U.S. per capita income of \$30,820. The per capita income is projected to be \$33,603 in five years, compared to \$34,828 for all U.S. households

Currently, 68.0% of the 5,770 housing units in the area are owner occupied; 23.7%, renter occupied; and 8.4% are vacant. Currently, in the U.S., 55.6% of the housing units in the area are owner occupied; 33.1% are renter occupied; and 11.3% are vacant. In 2010, there were 5,488 housing units in the area - 69.7% owner occupied, 22.2% renter occupied, and 8.1% vacant. The annual rate of change in housing units since 2010 is 2.25%. Median home value in the area is \$188,177, compared to a median home value of \$207,344 for the U.S. In five years, median value is projected to change by 4.12% annually to \$230,240.
